VI Edition - A.Y. 2022/2023

CALL FOR APPLICATIONS

ART. 1

Human Rights International Corner ETS (HRIC), with the scientific cooperation of the University of Milan - Department of Italian and Supranational Public Law, CNR-IRISS, and Wageningen University and Research, is offering a Summer School in *Business and Human Rights*. The Summer School will be held in Mantua (Sala delle Vedute, Biblioteca Teresiana, via Roberto Ardigò 13) from 13th June to 17th June 2023. The Summer School is supported by Comune di Mantova, Ordine degli Avvocati di Mantova (Mantua Bar Association) and Scuola Forense di Mantova. It is endorsed by the Inter-Ministerial Committee on Human Rights (CIDU).

ART. 2

The focus of the Summer School is on providing a frame of understanding of the main challenges concerning the intersection between business activities and human rights. Particular attention is paid to the role and obligations of States and corporations, with a focus on the human rights-related legislations regulating corporate activities worldwide and the access to effective remedies for victims of corporate-related human rights abuses. The Summer School will provide the participants with up-to-date insights into the business and human rights international debate, analyzing in depth the content of the UN Guiding Principles on Business and Human Rights and examining the practical implications of the current European, international and domestic developments in this field.

The Summer School addresses the needs of professionals, corporations, students, researchers, lawyers, NGOs, CSR specialists, public-and private-sector practitioners, public authorities (...) to deepen their knowledge in the field of business and human rights and provides them with skills and tools to operate.

ART. 3

The sessions are spread over five days, from Tuesday 13th June (from 9:00) to Saturday 17th June 2023 (to 13:00) and require participants' full-time commitment.

The content is divided into lectures and practical sessions and workshops on highly sensitive current developments in the field. The Summer School involves, as speakers and lecturers, well-renowned and distinguished academics, lawyers, practitioners, public institutions, NGOs, corporations, consultancies and professionals in the field.

The program of the VI edition will be released by the end of January 2023.

The working language of the Summer School is English.

The Summer School does not provide ECTS (University credits). It is accredited by the Mantua Bar Association (Ordine degli Avvocati di Mantova) and attributes 14 credits (crediti formazione professionale continua).

ART. 5

The Summer School accepts two modalities of enrollment. Participants may choose between: a) the in-person format in Mantua; b) the online format, with classes live-streamed in webinar modality. Participants in the webinar modality will be able to ask questions only via chat message. They will also be able to access the recorded lectures afterwards.

The Summer School accepts a maximum of 40 participants in person and will be activated with a minimum number of enrollments.

Should COVID-19 restrictions be imposed, consistent rules will be applied to the format and the students' attendance.

ART. 6

Application deadline is 1st April 2022. Applications received before 1st March 2022 will benefit from the early-bird registration fee. A discounted fee for students is available.

The fees are as follows:

Participants enrolled in the in-person format will be entitled to 5 light lunches and 5 coffee-breaks on all course days. The Summer School will also offer 1 evening social event. Accommodation in Mantua and travels are the full responsibility of the participants (a list of accommodations will be distributed to the enrolled participants at their request). Participants are strongly recommended to arrange their accommodation well in advance.

Applications must include:

1. The application form, specifying:
 - a. Surname, name, place and date of birth, citizenship
 - b. Address and contact details for any communication
 - c. Knowledge of English (basic / good / fluent)
 - d. Letter of Motivation

2. The applicant's CV/résumé

In case of failure of the online application system, applicants are advised to contact the Summer School Secretariat at: bhrsummerschool@gmail.com. Late applications, or applications missing any mandatory information, will not be taken into consideration.

ART. 6

In order to be eligible for the course, applicants must have a working knowledge of English (self-certification is admissible). The admission procedure will be held on a rolling basis (first come, first served). It includes an assessment of the applicants' qualifications and the letter of motivation. The organizers will assess the applications as they are submitted and will timely notify to applicants via email the admission decision, or their inclusion in the reserve list.

ART. 7

Admitted applicants shall send proof of payment of the fee by email (bhrsummerschool@gmail.com) within 7 days upon the receipt of the admission letter.

Art. 10

In accordance with the EU General Regulation on Data Protection 2016/679 (GDPR), art. 13, the Data Controller is Human Rights International Corner Human Rights International Corner – HRIC, C.so Vercelli, 57 – Milano (Italy) e-mail: segreteria@humanrightsic.org. The data are provided by the interested party when applying to the Summer School and the HRIC membership. We process the following data categories: (i) contact data: name, date and place of birth, citizenship, education information, phone number, e-mail address passports/IDs; (ii) bank information relating to payments in the case of payment of the fee. HRIC neither collects nor treats on its own initiative particular categories of personal data, including information revealing racial or ethnic origin, political opinions, religious or philosophical convictions, or the state of health of data subjects.

Personal data are processed during the time of service and for 10 years from the termination of service on the basis of the ten-year limitation period for contractual relationships and the provisions of art. 2220 c.c. regarding accounting records. With regard to HRIC membership, the data are processed until the data subject unregisters.
